<b>Title:</b>	<b>Revalidation of the licences, ratings, certificates and authorizations of flight crew personnel and flight dispatchers</b>

**OAM applicable to:**

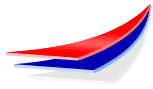
Holders of flight crew and flight dispatchers licences which are issued by the CAD Republic of Serbia

In accordance with the new situation regarding the Coronavirus virus (COVID-2019), the decisions and recommendations of the Government of the Republic of Serbia, Article 14, paragraph 4 of the common rules in the field of civil aviation and establishing a European Union Aviation Safety Agency ("RS Official Gazette" No. 23 / 12 and 104/17) and by decision of the Directorate No. 6/2-03-0008/2020-0082 valid from date 07.05.2020, regarding revalidation of licenses, ratings, certificates and authorizations the CAD will apply following decisions:

1. The period of validity of licenses, ratings, certificates and authorizations of flight crew and aviation dispatchers issued by the CAD of the Republic of Serbia shall be automatically extended for the period of 4 months from expiry date.
2. The period of validity of Class 1, Class 3 and cabin crew medical certificates shall be automatically extended for the period of 4 months from the expiry date in the certificate, providing there are no limitations endorsed other than visual ones.
3. The period of validity of aeromedical examiner certificates with privileges to conduct aeromedical examinations and assessments for Class 1 and Class 3 shall be automatically extended for the period of 4 months from expiry date in the certificate.
4. This operational notice will apply to all licenses, ratings, approvals and authorizations as well as medical certificates that expire before 31.07.2020.
5. Holders of licences issued by the CAD Republic of Serbia may use the exemption described in point 1 provided that they have previously completed refresher training and successfully passed the assessment. A report form of completed refresher training and assessment can be found in Attachment 1 to this Operational Notice.

This Operational Notice is an attachment to licence. All holders of licenses issued by the CAD of the Republic of Serbia are obliged to carry this notice, in print or electronic form, in order to exercise privileges from their licences.

This operational notice is effective from 07/05/2020.
