On the basis of the Article 13(2) of the Air Transport Law ("Official Gazette of the Republic of Serbia", No 73/10, 57/11, 93/12, 45/15, 66/15 - other Law, 83/18 and 9/20),

The Director of the Civil Aviation Directorate of the Republic of Serbia, with the consent of the Ministry of Defense and the Ministry of Interior, enacts

## **ORDER**

## on determination of restricted areas LY R10 Uvac, LY R11 Tresnjica and LY R12 Milesevka

"Official Gazette of RS", No 128 of 26 October 2020

- 1. This Order determines the restricted areas LY R10 Uvac (hereinafter referred to as: LY R10), LY R11 Tresnjica (hereinafter referred to as: LY R11), and LY R12 Milesevka (hereinafter referred to as: LY R12), as well as conditions for civil aircraft flights within these areas.
- 2. LY R10, LY R11 and LY R12 are parts of the airspace of the Republic of Serbia determined by the following vertical and horizontal borders:
  - 1) vertical border: 2.100 m altitude;
  - 2) horizontal border is determined by lines connected in points with the following geographical coordinates:

3. The flight of civil aircraft, including unmanned aircraft, within the areas referred to in Item 1 hereof shall be allowed only if the aircraft operator has obtained the flight permission, issued by the Civil Aviation Directorate of the Republic of Serbia.

- 4. An application for issuing the flight permission referred to in Item 3 hereof shall be submitted 30 days prior to the intended flight at the latest.
- 5. The flight permission referred to in Item 3 hereof shall be issued when the following conditions are met:
  - 1) when a submitted consent of the manager of the protected area located within the areas referred to in Item 1 hereof, is issued in accordance with the law that governs nature protection;
  - 2) when all the conditions for the safe aircraft flight are met;
  - 3) when an aircraft, except in the case of unmanned aircraft, is equipped with SSR transponder Mode S or Mode S;
  - 4) when for an intended flight a positive opinion is given by the ministry in charge of internal affairs and the ministry in charge of defense.
- 6. An aircraft operator who is issued the flight permission within any of the areas referred to in Item 1 hereof shall all the time keep the SSR transponder on during the flight.
- 7. This Order shall not be applicable to aircraft in emergency, aircraft operating urgent medical flight, aircraft participating in firefighting or search and rescue or when the civil aircraft is used for operational activities of the ministry in charge of defense or the ministry in charge of internal affairs.
- 8. This Order shall enter into force on the eighth day following that of its publication in the "Official Gazette of the Republic of Serbia".
