AMENDMENT TO COMPETITION DOCUMENTATION FOR PUBLIC PROCUREMENT OF LAW-VALUE SERVICE – SPECIALIST CIVIL AVIATION TRAINING



Pursuant to Article 61 of the Law on Public Procurement ("Official Gazette of the Republic of Serbia" No. 124/12, 14/15 and 68/15) and Article 6 of the Rulebook on Compulsory Elements of Tender Documents in Public Procurement Procedures and Method of Proof of Compliance ("Official Gazette of the Republic of Serbia", No. 86/15), and in connection with the Decision on initiating the procedure for public procurement of low-value service -Specialist Civil Aviation Training (No. 8/8-02-0003/2017-0002 of July 04, 2017) and the Decision on establishment of the Public Procurement Commission for the Low-Value Service - Specialist Civil Aviation Training (number 8/8-02-0003/2017-0003 of July 04, 2017)

AMENDMENT TO COMPETITION TENDER DOCUMENTATION

For public procurement of low-value service - Specialist Civil Aviation Training Serial number JNMV 18/2017

1. In the tender documentation for Public Procurement of low-value service - Specialist Civil Aviation Training, JNMV Documentation Number 18/2017, item 6. The tender form, part of the terms of the offer, indent 6 are amended to read as follows:
"Price of the fourth training – NAA inspectors training course - initial airworthiness, according to the Technical Specifications, is euros".
2. In item 13 <i>Model of Procurement Contract</i> , Article 3, paragraph 5 is amended to read as follows:
"Price of the fourth training – NAA inspectors training course - initial airworthiness, according to the Technical Specifications, shall be euros."
3. In item 13 Model of Procurement Contract, Article 7, paragraph 5 is amended to read as follows:
"The fourth training course – NAA inspectors training course - initial airworthiness, shall be held from 16 to 18 January 2018 and the number of participants shall be 7."
4. In item 14 Technical Specifications, technical characteristics and requirements as

part of the fourth training is amended to read:

EU Regulation (EC) 216/2008 of 20 February 2008 addresses amongst others the responsibilities of National Aviation Authorities of the Member States of the European Union regarding the implementation and training of National Aviation Authorities Inspectors responsible for Initial Airworthiness.

"FOURTH TRAINING - NAA INSPECTORS TRAINING COURSE - INITIAL

In order to fulfill these requirements the European Commission has issued Regulation (EU) No 628/2013 of 28 June 2013 on working methods of the European Aviation Safety Agency for conducting standardisation inspections and for monitoring the application of the rules of Regulation (EC) No 216/2008 of the European Parliament.

The European Commission has also issued implemented Commission Regulation (EU) No 748/2012 of 3 August 2012 laying down implementing rules for the airworthiness and environmental certification of aircraft and related products, parts and appliances, as well as for the certification of design and production organizations.

This training course should provide National Aviation Authorities' Inspectors to become knowledgeable and capable to fulfill the obligations of standardization per (EU) No 628/2013 and the certification of production organizations per (EU) 748/2012.

*Content

In this course there should be addressed chapters and articles of the following EU Regulations: EU Regulation (EC) 216/2008

Commission Regulation (EU) No 628/2013

Commission Regulation (EU) No 748/2012, the relevant Subparts of Annex I (Part-21)

* Objectives

By the end of the training course, the NAA Inspector shall not only be able to:

- · identify, and
- justify

the findings with regard to Initial Airworthiness, according to the European regulatory framework currently in place, but should also be fully knowable how to manage production application under Subpart F, respectively Subpart G and how to manage and perform the continued oversight of these organizations."

- 5. In item 15 Price Structure Form in the table under number 4 the title is changed to read "NAA inspectors training course initial airworthiness".
