#### REGULATION

## amending Regulation on the conditions for performing air operations

### Article 1

In Regulation on the conditions for performing air operations ("Official Gazette of RS", No 9/18), Article 2 (1) (11) shall be amended as follows:

"(11) Commission Regulation (EU) No 748/2012 means Commission Regulation (EU) No 748/2012 of 3 August 2012 laying down rules for the airworthiness and environmental certification of aircraft and related products, parts and appliances, as well as for the certification of design and production organisations. This Regulation has been applied in the Republic of Serbia by Regulation on certification of aircraft and other aeronautical products, parts and appliances and on issuing maintenance licences for design and production organisations ("Official Gazette of RS", No 5/18);".

#### Article 2

In Addendum 1, Annex VII (Non-commercial air operations with other-than complex motor-powered aircraft (Part-NCO)), in Subpart B (Operational procedures), point NCO.OP.126 Fuel and oil supply- helicopters, in paragraph (b) point (3) word: "aeroplane" shall be replaced by word: "helicopter". \*

The title of point "NCO.OP.190 In-flight fuel management" shall be amended as follows: "NCO.OP.185 In-flight fuel management".

The title of point "NCO.OP.195 Airborne collision avoidance system (ACAS II)" shall be amended as follows: "NCO.OP.200 Airborne collision avoidance system (ACAS II)".

#### Article 3

In Addendum 1, Annex VIII (Specialised operations (Part-SPO)), Subpart A (General requirements), the title of point "SPO.GEN.150 Release of dangerous goods" shall be amended as follows: "SPO.GEN.155 Release of dangerous goods".

In Subpart B (Operational procedures), point SPO.OP.131 Fuel and oil supplyhelicopters, in paragraph (b) point (3) word: "aeroplane" shall be replaced by word: "helicopter". \*

In Subpart D (Instruments, data, equipment), Section 2 (Helicopters), the title of point "SPO.IDE.H.255 Transponder" shall be amended as follows: "SPO.IDE.H.225 Transponder".

# Article 4

This Regulation shall enter into force on the eighth day from the day of its publishing in the "Official Gazette of the Republic of Serbia".
